

MUNICIPALITY OF RAVELLO - TOURIST TAX



It is hereby informed that the City Council, by resolution No. 6 of 28.03.2018, approved the establishment of the Tourist Tax and the related Municipal Regulations.

The rates to be applied were then updated by Resolution No. 31 of 03/20/2019. Therefore, in the period from April 1 to October 31 each year, Tourists staying overnight at the accommodation facilities, hotel and extra-hotel, located in the territory of the Municipality of Ravello, will have to pay the 'tourist tax, for the first 7 (seven) nights, to the manager of the facility who will then have to pay this Amount to the Municipality.

The deliberated amounts to be applied, per person and per overnight stay (up to a maximum of seven consecutive nights) are as follows:

Exemptions

1. The following are exempt from paying the tax:

(a) minors under the age of sixteen;

(b) the handicapped who must show the manager appropriate documentation; (c) political refugees;

(c) political refugees; (d) members of the forces of law ar

(d) members of the forces of law and order who stay in accommodation facilities as a

result of measures adopted by public authorities to deal with situations of a social nature, as well as emergencies resulting from calamitous events or of an

extraordinary nature or for humanitarian relief purposes:

(e) Volunteer personnel of the Civil Defense and Red Cross and NGOs who carry out similar activities and serve during disasters;

(f) National and international school teaching personnel of any grade and order, in the performance of accompanying activities;

(g) Bus drivers and tour leaders who provide activities of

assistance to groups organized by travel and tourism agencies. The exemption shall

applies for each coach driver and one tour leader for every 20 participants.

2. The exemption under (c) is subject to the presentation of the card certifying political refugee status issued by the competent Territorial Commission for the Recognition of International Protection.

3. The exemption under (f) is subject to the submission of appropriate self-certification stating that the stay at the accommodation is due to the circumstances stipulated in the same point f).

4. Evidence of the exemptions referred to in this article must be kept for 5 years at the accommodation facilities and exhibited in any checks by the City of Ravello.
